Action Items for Immediate Consideration:

A. New Hires

Nicole Airgood introduced new teaching hires Morgan Pueschel and Amber Peters. There was a motion to approve the hiring of teachers by Mr. Swihart with support from Mrs. Halling. 6 ayes, 0 nays, motion approved.

B. SEA/SPS Collective Bargaining Agreement

Dr. Ebert reviewed the process and thanked the bargaining team for their hard work. The agreement includes a 1% increase and two years of school year calendars. He added that the first semester will now end with the winter break. There was a motion to approved the agreement by Mr. Swihart with support from Mrs. Bird. 6 ayes, 0 nays, motion approved.

C. English Language Arts Curriculum Resources

Ms. Airgood reviewed the recommendation and noted that the 30-day window for public comment has passed. There was a motion to approve the request by Mrs. Bird with support from Mrs. Halling, who commented that she hopes to see more technology in the future. 6 ayes, 0 nays, motion approved.

Action Items for April 20:

A. SHS HVAC Repairs Recommendation

The system needed a thorough review for repairs and a bid. There was only one bid received.

B. Wenzel Playground Vendor Recommendation

Mr. Sterling asked if a board member might be interested in participating in interviews of potential vendors later in the week. Wenzel staff will also be included. There will be a recommendation by end of day Friday.

C. Transportation Recommendation

Mr. Sterling shared options with the board and offered the recommendation to purchase two buses.

In administrative reports Mr. Sterling is working on the monthly review for projections and the 2020-2021 budget. Repairs on Wenzel bathrooms and the pool project have been moved up to May due to the shutdown.

Ms. Airgood thanked all who are learning new ways with distance learning. Kudos to Robert Taylor, Doug Camburn, Patti Miller, the EA's, and tech department in addition to the teaching staff.

Dr. Ebert noted that today was the first day of distance learning and commented that so many have stepped up. We are distributing approximately 2,000 meals per day and have distributed 1,300 ChromeBooks to students/families who requested them.

In Board Comments Mrs. Bird congratulated Dr. Ebert and Ms. Airgood on the document prepared for online learning. Mrs. Halling expressed gratitude to all for adapting to the drastic changes. Today was a little overwhelming as she began homeschooling her children but smoother as the day went on. Mr. Swihart is currently quarantined from his son, but asked about his day. It was an "amazing day" and assignments were clear and challenging. Mrs. Donmyer echoed comments by Mrs. Halling as she is also suddenly homeschooling several students. Mr. Boland is proud of everyone's efforts and heard that his daughter's day went well.
