### Article XVIII - Professional Compensation/Extra Duties

This letter of agreement will become effective upon Board approval and will extend until the end of the current contract in August 30, 2019.

Unchanged: Pay rate will be paid on a percentage basis and based on the bachelor's column (Column A) of the adopted salary schedule for the current year. Individuals having extra duties will begin at the bottom level regardless of teaching experience, unless the individual has had experience in the specific area of extra duty responsibility.
